## **Financial Report**

We still have a large chunk of money in First Security Bank checking. Post 1 gaming is a quarterly check to the post. Post 1 has not received a recent quarterly check. Mamie just received the quarterly statement so the checks will be written this week. Post 1 has not received quarterly checks for awhile due to the post being in the red when we lost Jacks and Rusty's gaming sites. The gaming committee decides when the quarterly checks will be written to the post.
